#### 1. Introductions:

The Vice Chairperson Martina Moloney welcomed Minister Katherine Zappone to meet the Steering Group and outlined the role and goals of the Steering Group for the Minister. Minister Zappone emphasised how the work of this group is integral to her own work and the work of the Department to demonstrate that we must focus on improving outcomes for children and young people and removing barriers to their potential. The Minister noted:

- the leadership from this group
- the work of CYPSC at local level as vehicles for change
- the work of CYPSC as ambassadors for interagency working which ultimately is about building relationships and trust.

On behalf of the Steering Group Martina Moloney thanked the Minister for her support and assured her that this group is keen to deliver on its mandate.

Martina Moloney welcomed Willie McIntosh to the Steering Group as the new representative from the Department of Education and Skills.

#### 2. Minutes of last meeting and matters arising:

-Sub group with Advisory Council on C&V sector engagement in CYPSC: DCYA are currently seeking a meeting date for all concerned. The purpose of this sub-group is to consider the form and levels of engagement and representation of the Community and Voluntary (C&V) sector on CYPSC and their subgroups.

An update will be provided at the next meeting.

#### -Status of CYPSC Co-ordinator appointments:

Mary Hargaden updated the group on the transfer of CYPSC posts into Tusla and the status of appointments to vacant posts. The group was also informed that the time from offer to appointment is taking longer than anticipated. Tusla are taking steps to address this.

#### -Update on CYPSC National Implementation Group:

Mark Considine updated the group on the new CYPSC National Implementation Group. This group held their first meeting on 18<sup>th</sup> May. It will support management, co-ordination and operation of CYPSC between DCYA, Tusla-Child and Family Agency and the National Coordinator for CYPSC. The Terms of Reference for this group and the minutes from their meetings will be circulated to the CYPSC NSG. Membership of this group is Colma Nic Lughadha (National Co-ordinator), Mary Hargaden (Tusla), Eifion Williams (Tusla), Conor Rowley (DCYA) and Mark Considine (DCYA).

#### -Chairperson for NSG:

Conor Rowley updated the group that a number of suggestions for Chairperson will be discussed with the Minister for Children and Youth Affairs. Any views from the Steering Group are welcomed. It was agreed that the Chairperson be a person with public sector experience, an understanding of the Community and Voluntary sector, and with a commitment to children and young people and have interagency-working experience. Any suggestions can be sent to





Conor. It was agreed that a new Chairperson be in place by the next Steering Group meeting and in time for the National CYPSC Seminar.

### -Guidance on the Participation of children and young people in CYPSC:

Mark Considine updated the group that a second draft of the guidance for CYPSC on Participation will be sent to the Reference Group working on it and then on to the local CYPSC for their observations. SG members emphasised the importance of local committees being consulted regarding the guidance document. The Steering Group recognised the importance of children and young people being in the conversations affecting them in an age-appropriate manner.

*-Feedback from the Children and Young People's Policy Consortium meeting March 2016:* Conor Rowley updated the group on 4 items brought to the Children and Young People's Policy Consortium from the NSG, in March.

- 1. Re member from Department of Social Protection (DSP) on local CYPSC: DSP gave no commitment on standing presence on CYPSC but will attend for meetings where needed and can follow up on issues bilaterally.
- 2. Re seniority of membership on CYPSC: there is a clear mandate and clear support for CYPSC and the Secretary General of DCYA as Chairperson of the Children and Young People's Policy Consortium will continue to drive this support.
- 3. Re finance for CYPSC: there is commitment to secure contributions from key agencies to fund local initiatives. This will continue to be explored.
- 4. Re buy-in to CYPSC planning: Consortium members were asked to reference CYPSC in their plans and to underscore the importance of communications with CYPSC

The Chairperson summarised the discussion that followed and noted that it was fundamental to the work of CYPSC and to building relationships and trust that there is no "opt out" by one agency. DSP presence on CYPSC will add impact in particular where it has been noted that CYPSC need emphasis on Outcome 4, Economic Security and Opportunity. Conor Rowley suggested that the DSP be asked for a nominee to the CYPSC SG. This was agreed. CR to write to the DSP to arrange further discussion and convey the CYPSC SG opinion that membership is necessary if engagement is to be meaningful and work to be productive. It was also agreed that the CYPSC SG's response be relayed back at the next Children and Young People's Policy Consortium meeting.

The minutes of 24<sup>th</sup> February 2016 were agreed and will be published online on www.cypsc.ie .

#### 3. National Update on CYPSC implementation:

Colma Nic Lughadha presented a National CYPSC Implementation Update Report for the period January to June 2016 providing a high level overview of CYPSC implementation.

Discussion followed noting that Child and Youth Mental Health is a prominent theme being addressed by CYPSC. Given developments nationwide in particular the work of the National Office of Suicide Prevention (NOSP) and of Jigsaw, the need for joined up working on youth mental health with a HSE lead was noted. It was agreed to raise at the next Children and Young People's Policy Consortium meeting the need for co-ordination regarding Youth Mental Health.





The National CYPSC Implementation Update Report also indicated that the greatest number of local CYPSC activity is reported under Outcome 1 Active and Healthy; illustrating the clear potential of CYPSC to support the implementation of national policy on health. The approach taken regarding the engagement by the HSE with Local Community Development Committees, led by Healthy Ireland, was noted. It was agreed to seek clarification from the HSE at the next Children and Young People's Policy Consortium meeting regarding a HSE lead for CYPSC engagement noting the productive approach utilised in the LCDC context.

### 4. Local view on CYPSC Implementation:

Angela Toolis and Caroline Duignan provided a flavour of the work being done by Galway CYPSC and Roscommon CYPSC including work to:

- Address the impact of parental mental health on children and young people
- Scale up county-wide supports for positive transition from pre-school to primary school
- Promote internet safety
- Develop Guidelines for Youth Party Night organisers
- Develop a LGBT Support Code of Practice
- Develop a Homework support club
- Build youth participation in Clifden

The Vice Chairperson thanked Caroline and Angela for these examples of local CYPSC work.

#### 5. NSG Work Plan 2016 -2017:

The group worked through the items on the Work Plan amending as necessary and assigning responsibility for items among the membership. Actions pertaining to commencement of delivery of the Work Plan are included in the "Actions from the Meeting" table on page 1.

The Work Plan 2016-17 was agreed and is provided at Appendix 1.

It was agreed that key action 3.1.2 "Explore contributions from state agencies to a programme budget for CYPSC" and an update from HSE on new initiatives should be Agenda items for the next meeting.

#### 6. Planning and Reporting Framework for CYPSC – Issues for consideration:

Colma Nic Lughadha provided some initial notes on the features of planning and reporting frameworks for discussion on what the Steering Group would like to see captured in CYPSC reporting. The group noted the following:

- Evidencing the value of CYPSC
- Plans that are succinct, accessible, timely and outcomes focussed
- Measuring the process of CYPSC
- Having Children and Young People's Plans in place
- Evidencing change and impact for children and young people

It was agreed that CYPSC Planning and Reporting be an Agenda item for the October meeting.

#### 7. Presentations on Commissioning:

Conor Rowley circulated a briefing document on Commissioning. Due to time constraints at the meeting it was agreed that the group would consider this paper and send any observations on it to Conor. Mary Hargaden noted that the Tusla Commissioning work is in 5 pilot sites at the moment, matching needs and resources.- It is anticipated that by Q3 2016, the learning from these sites will aid Tusla planning with DCYA for 2017.

Commissioning will be an Agenda item for the October meeting.





### 8. National Seminar for CYPSC:

A brief discussion was held on holding the national CYPSC Seminar in 2016 or pushing it out into 2017. Development opportunities regarding CYPSC Leadership support, noted in the National CYPSC Implementation Update Report, plus the provision of training to newly appointed and existing CYPSC Co-ordinators will require sufficient allocation of time in 2016. The benefits of holding a national CYPSC Seminar in terms of promoting inter-CYPSC learning as well as engaging with external stakeholders to promote engagement with CYPSC were noted. A combination of these to be considered by the National Co-ordinator for CYPSC for 2016. Suggested themes for a national seminar can be sent to Colma Nic Lughadha.

#### 9. Messaging/Items fao the Consortium:

The next Children and Young People's Policy Consortium meeting is on Thursday 23<sup>rd</sup> June. The Vice Chairperson is not available to attend. A substitute will be sought. Items to be brought to the attention of the Consortium

- 1) Importance of DSP membership on CYPSC
- 2) HSE lead for engagement with CYPSC noting the approach utilised regarding LCDC engagement by HSE.
- 3) Co-ordination of Youth Mental Health policy and provision.

#### 10. Any other Business:

Caroline Duignan informed the meeting that she is studying for a PhD. Her research topic is understanding the impact of interagency structures. Caroline may be calling on members of the Steering Group to participate in her research and will share her findings.

Julie Heslin questioned if the Health representative on this group should be a Department of Health person. Conor Rowley will follow up to discuss with Kate O'Flaherty of Healthy Ireland.

The Vice Chairperson requested that the new Programme for Government (PFG) be circulated to the Steering Group and that a discussion on elements of the PFG impacting on CYPSC be an Agenda item for the next meeting.

The next meeting is scheduled for Thursday 13<sup>th</sup> October 2016 in DCYA, Mespil Road.
